We have just completed the first of our current five-year Strategy, which is reflecting well by the outputs, relationship building and global profile we are achieving.

Although it provides a snapshot of some of the Institute's projects and work; it cannot come close to detailing the range, volume and quality of activities we, as a collective team of members, staff and volunteers, are involved with and have worked on.

We support our members and those wishing to become Architectural Technology professionals across the globe, we have the largest number of Accredited Programmes, and now also outside of Europe. We are invited to speak at conferences around the world, we have had Members invited to present papers in places such as Spain, Denmark, Dubai, India and Australia alongside the UK and Republic of Ireland.

As specialists in the technology of architecture; a creative, innovative design discipline rooted in science and engineering, we pride ourselves on what we can give back to the industry, and are key contributors on consultations across the home nations and Republic of Ireland.

We were a lead in Scotland on the changes that were necessary following the building failures and the recommendations in the Cole Report.

In England, we have had regular meetings with the Ministry of Housing, Communities and Local Government (MHCLG) working with them to implement the recommendations and way forward to Building a Safer Future and the review of the competency framework for competent professionals to work on higher risk residential buildings (HRRBs) led by the Competence Steering Group.

My role as President is to promote, network and engage; this has been a pleasure to do on your behalf. I have travelled to a range of locations within the UK, and across the globe, to promote the discipline and engage on your behalf.

I have represented the Institute at a variety of events and forums. I could highlight many, but one of significant importance was the cross-Institute event held at Futurebuild in March. A CIAT initiative where President's or senior representatives from the principle Institutes gathered to debate key issues such as Building a Safer Future. This event was truly collaborative and so successful, Futurebuild has now incorporated this format into the schedule for the main stage in 2020.

Operationally, the Electoral Review closed with many of the recommendations having been implemented to ensure members are more engaged with their Institute. The refurbishment of City Road, the Institute's home, was held back as the project was reconsidered with a larger refurbishment to make the City Road premises fit for purpose for a longer period of time. This project is due to start on site in January 2020.

The Membership Grade Review has also reached its conclusion with the recommendations forming Resolutions for the 2019 AGM. Watch out for information
