The UK Net Zero Carbon Buildings Standard will set out the requirements for achieving and verifying a built asset as net zero carbon in the UK market. It will be applicable to new and existing buildings. The initiative is collaboratively led by industry bodies and organisations with extensive knowledge and influence in the built environment sector, aiming to develop the reference guidance for robust net zero claims for single assets, backed by science.

We need the whole built environment industry to support the development of this Standard.

There are various ways of getting involved in this Standard, either through participating in one of the Task Groups, the sector groups, which will be developing sector specific targets, providing data on operational energy and embodied carbon or supporting with other roles, such as coordination and project management.
