NSAI Call for Members

NBCO & MSO Notice



Opt-Out of Statutory Certification -Promoting Compliance with Section 11(3)(c) Requests

The National Building Control and Market Surveillance Office (NBC&MSO) have circulated a notice to Building Control and Chief Fire Officers, clarifying the use of the term 'Opt-Out (S.I. 365 of 2015)'.

" It is time that we started to ensure that only competent people are engaged in the construction process as the lack of professionals (i.e. builders, owners, designers, who engage with continuous CPD every year) is causing serious issues for the health, safety and welfare of people in or about buildings" writes Mairéad Phelan, Head of the National Building Control & Market Surveillance Office.

This signals a renewed focus on Commencement Notices with Opt-Out Declarations.

What does this mean?

Section 11(3)(c) requests target Building Regulation Compliance issues - specifically focussing on main structural elements and energy performance covered by Part A, Part C, Part, D and Part L - and the use of construction products that are fit for the use for which they are intended. It does not negate the requirement to seek compliance on other parts of the Second Schedule which are identified by a desktop / site inspection.

Building Control Authorities have been encouraged to target practices who promote or consistently use the Commencement Notice with Opt-Out Declaration for Section 11(3)(c) requests.

Important Update on the Architectural Technologists Register (ATR)

Further to the meeting in March with the **Department for Housing**, **Local Government and Heritage**, where they undertook to bring

forward the legislative proposals to establish the ATR as a Statutory Register, we are in the process of forming the necessary **ATR** Boards (Admissions; and Conduct and Appeals). The Department require these to demonstrate its effective operation upon which we must push for the Minister to make the necessary changes to the primary legislation to establish the Register as a Statutory Body, enabling **Registered Architectural Technologists** to act as **Design and Assigned Certifiers** under **BC(A)R 2014**.

Members and affiliates are encouraged to register on the **ATR** (currently in shadow operation) or register their intent to join by visiting the website;

www.architecturaltechnologistsregister.ie.

We ask that you maintain sustained pressure on the Minister/Department via their local TDs to ensure we can achieve a **Statutory Register** as soon as possible. It is essential that all CIAT members and affiliates prevail upon their unaffiliated Architectural Technologist colleagues to assist CIAT in gaining the appropriate recognition for our profession by joining CIAT and/or registering on the **ATR**.

Update on judgement to protect use of words 'architecture' and 'architectural'



Members and affiliates will be aware of the **District Court** judgement made on 11 March 2022 for the unlawful use of the word 'architectural' where the business was not under the control and management of a registered architect.

For **Chartered Architectural Technologists**, there is no restriction on the use of the words 'architecture' or 'architectural' when used as part of a registered company name or professional trading style. The use of these words forms part of their right to describe their practice and the provision of the skills and services within their field which is integral to the discipline for which they are qualified.

Loft Conversion Guidelines - April 2022

> Loft Conversion Guidelines Protect Your Family - Fire Safety Guidance



The Loft Conversion Guidelines – Protect Your Family – Fire Safety Guidance (2022) were developed in recognition of the provisions of Technical Guidance Document B, 2017, and replace the Loft Conversion Leaflet, published in 2004.

Converting roof space is a convenient way of obtaining additional living space in an existing dwelling house.

But, there are many issues which must be resolved before works are carried out. Under the Building Control Act 1990 – 2020, there is a legal requirement placed on the owner / builder / designer to ensure that the finished works comply with the Building Regulations. The guidelines highlight the principal issues (including fire safety) that need to be addressed when converting an attic / loft roof space in an existing dwelling house.

Contents include; Professional Advice, Fire Safety, Legal Requirements, Escape Provisions, Protection to Structural Elements, Fire Detection and Alarm Systems, Electrical Installations, Houses of Architectural / Historic Importance.

OneClick LCA CPD Event

On 5 May, the Republic of Ireland Centre hosted an **aspirATion** event in conjunction with **Xtratherm**.



The training event, presented by Johanna Jarvinen of **OneClick LCA**, was a hybrid event hosted from TU Dublin and attended on site with lecturers and students from colleges across the country.

OneClick LCA is a life cycle assessment tool that can quantify and assess the life cycle embodied carbon of buildings and their construction materials. The whole life cycle assessment tool is a sophisticated programme which allows the user to make environmental choices at an early design stage by comparing materials from cradle-to-grave to optimise the performance of the building.

The software allows for Revit plug-ins and credits can be achieved from LEED, BREEAM and other Green Building Certification. EPDs (Environmental Performance Declarations) are third party verified and listed, allowing the designer to make informed decisions regarding their choice of material and their environmental impact, from across international markets.

Whole building life cycle assessment is a new and emerging discipline. There are great opportunities for Chartered Architectural Technologists to lead the way in this field. IGBC 'Build Green New' Conference

The **IGBC** hosted their '**Build Green Now**' conference in the Gibson Hotel, Dublin on 6 May 2022. The zero carbon event focused on Environmental, Social and Governance (ESG).

Pat Barry, CEO of **IGBC**, launched the draft publication '**Net Zero Whole Life Carbon (WLC) Roadmap for the Built Environment in Ireland**'. A consultation period was opened and has now closed on 7 July 2022 last.

The conference had an opening address from Eamonn Ryan TD – Minister for Environment, Climate, Communications and Transport. Lively panel discussion followed with Ali Grehan – Dublin City Architect, Francis Noel Duffy TD – Green Party Spokesperson for Housing, PJ Rudden – Aengus Consulting and Orla Coyle – SEAI. Further panel discussions continued after the (very low carbon) vegetarian lunch. Panelists from industry providers, manufactures, investors and housing organisations discussed ESG meeting zero carbon and the challenges.

John Gibbons environmental journalist, and weekly columnist on 'The Last Word with Matt Cooper' gave a stark presentation of the climate emergency.

The conference ended with Eoin O'Broin TD – Sinn Fein, Frances Fitzgerald MEP – Fine Gael, Ciaran Cuffe MEP – Green Party and Cian O'Callaghan TD – Social Democrats discussing Building Political Consensus.

Architectural Technology Summer Camp

The Young Enterprise Project (YEP)! Architectural Technology Summer Camp was delivered in the Atlantic Technological University (ATU) Galway City campus from 13-17 June 2022. In an architectural technology studio, a Computer Aided Drawing (CAD) room and an engineering laboratory room, 20 secondary students participated from the ages of 13 to 17 years of age for the week. The camp was supported by the Higher Education Authority for participants from DEIS schools.

The summer camp was led by Irene Hayden MCIAT with support from Gerard Nicholson ACIAT, Mark Deegan, and Mary Rogers, Head of Department in Building and Civil Engineering. All lecturers are on the CIAT-accredited Architectural Technology programme in ATU, Galway.

The opportunities for innovation, business development, enterprise, and research and development in architectural technology are plentiful, with digital transformation, virtual reality, circular economy architectural technology modular design, site-based automation, and sustainability goals representing some of the many entrepreneurial possibilities for business development in these areas for the next generation to capitalise on.

The camp involved delivering project-based learning in a studio setting. It included lectures with guest speaker Martin Meehan FCIAT, practical exercises and tutorials with David Ross MCIAT, and design advice. Students were engaged in practical activities, from design understanding and idea generation, sketch design and model making using a variety of materials, 2D and 3D illustration and design, as well as digital transformation, to the preparation of final presentation pieces to represent a design solution for an innovative and entrepreneurial proposal. Architectural sketching was encouraged both on campus and as part of a sketching and walking tour of medieval Galway City.

Atlantic Technological University Liam Cotter MCIAT and Mel McGerr FCIAT judged the final competition winners on the last day. Prizes were awarded to participants based on the quality of the architectural technology designs and/or business designs and their pitching of those ideas to the judges. Inclusion of a competitive aspect to the camp helped to stimulate creation and enterprise, thereby helping participants develop confidence, creative ideas, entrepreneurial thinking, public speaking, teamwork, and leadership skills.

Architectural Technology Consortium Apprenticeship

with Michael O'Keeffe FCIAT, Centre Chair and Councillor

On Thursday, 23 June 2022, a symposium to enable industry, educational and professional body stakeholders to explore the merits of a consortium apprenticeship for the discipline of Architectural Technology was held at **TU**, **Dublin (Bolton Street)**. The hybrid event was well attended nationally and generated great discussion.

Following an opening address from Prof. James Curtin, Dean of the Faculty of Engineering and Built Environment, Cormac Allen, Assistant Head of School (Architectural Technology) presented the running order for the day and posed some key questions for attendees to consider during the presentations.



Dr. Ruaidhri Neavyn (Higher Education Authority) gave a background to apprenticeships in Ireland, an insight to the new '**Action Plan for Apprenticeship 2021-2025**' and a high-level walk-through of the Apprenticeship Development Process, which a new Architectural Technology Apprenticeship would have to follow.

Following an industry perspective by Arthur O'Brien of C+W O'Brien Architects, Cormac Allen returned to discuss current AT course structures, key features of apprenticeships and the need for an AT Apprenticeship to be benchmarked to professional body standards to facilitate subsequent recognition.



After a brief refreshment break, **Dr. Suha Jaradat FCIAT**, Associate Professor & Programme Leader for Architectural Technology, presented on the Graduate Apprenticeship programme she designed and delivers in **Edinburgh Napier University**. This generated the most discussion of the day with attendees absorbed by the

apprenticeship delivery structure and how the course was combined with other disciplines (Building and Quantity Surveying) being delivered.

Declan Allen, Assistant Head of School, TU Dublin School of Business and Aidan Flynn, Chair of LAA Consortium, presented on the development of their **Logistics Associate Apprenticeship**. This proved beneficial in understanding the steps of the process to arrive at a successful consortium apprenticeship, connected to professional bodies.

Finally, Kirk McCormack, Programme Chair of BSc(Hons) Architectural Technology, gave a very interesting presentation on the routes and development of architectural education from 1600 AD to present day. A graphic he prepared is well worth reviewing together with the entire presentation which delves into the cost of architectural education in the past and the foundation of professional bodies. He also presented examples of how students are educated from digitalisation to practical exercise by constructing and testing models and the importance of this for application in the real world.

In conclusion, the event was hugely beneficial and the interest from industry in supporting an AT apprenticeship is clear. A timeline to progress the apprenticeship is currently being prepared and we will keep members and affiliates updated.
