### Important News

Work is progressing with the Department of Housing, Planning, Community and Local Government regarding the establishment of a **Statutory Register of Architectural Technologists**, which will enable Registered Architectural Technologists to act as Design and/or Assigned Certifiers under the **Building Control (Amendment) Regulations**.

**ATR** 

The framework and standards for the Statutory Register are set by the Building Control Act and the Minister. It is anticipated that the procedures to be established will mirror those currently in operation, such as those for Building Surveyors. The framework for assessing competence for Architectural Technologists to act as Design and Assigned Certifiers under the BC(A)R should follow that established by CIAT and the voluntary Register which will include the National Educational Standard for Architectural Technology published by QQI (Quality Qualifications Ireland) in March 2016, which sets the underpinning knowledge requirements with additional practice based competency assessment to ensure Architectural Technologists meet the standards required for Registration.

Following a recent parliamentary question, the Minister for State, Damien English TD, said "My Department supported the establishment by CIAT of the voluntary register for Architectural Technologists in Ireland in July 2014, to represent those practising in the Republic of Ireland. In March 2016, QQI formally published the National Graduate Standard for Architectural Technology in Ireland. This was the result of close collaboration between QQI, CIAT and RIAI. Since the publication of the QQI Standard, my Department has met with CIAT representatives to provide guidance and an explanation of the process involved in order to place the register on a statutory footing . . . . Following the meeting, my Department has provided follow-up information to CIAT regarding the preparation of a Regulatory Impact Analysis (RIA) in relation to the creation of a statutory register . . . . My Department will continue to engage and work with CIAT in relation to this matter."

CIAT is leading on the process and has set an ambitious timetable to ensure that the Statutory Register is achieved as soon as possible. However, issues such as the consultation and legislative processes and the Minister's responsibilities within the legislation may be outside the control of CIAT. We will continue to keep members advised of progress on this matter.
