#### Important Update

Following the publication of the QQI (Quality & Qualifications Ireland), National Standard for Architectural Technology, a meeting took place on 12 September 2016 between CIAT and the Department of Housing, Planning, Community and Local Government regarding the establishment of a Statutory Register of Architectural Technologists, which will enable registered Architectural Technologists to act as Design and/or Assigned Certifiers under the Building Control (Amendment) Regulations.

As you are probably aware, CIAT, with the support of the Department, has established a voluntary register of competent Architectural Technologists (ATR) and, as this register will form the basis of a statutory register, I urge all CIAT members to prevail upon their unaffiliated Architectural Technologist colleagues in the country to lend their support by joining their professional Institute and registering on the ATR. ### **Education Bursary**

The Committee is presently preparing a submission in response to a Public Consultation on revised **Building Regulations Part B – Fire, Draft TGD B2 - Dwelling Houses** (TGD B1 – Buildings other than Dwelling Houses has not yet been published for Public Consultation).

The Committee is also working on a submission in response to a Public Consultation on **Draft Guidelines for Part V (Social Housing)** agreements under the Planning & Development Regulations. There are several other recently published documents which require review by the Technical Committee, and the Committee would appreciate any offer of help from members who feel they could contribute.
