COVID-19 | CIAT Information and Advice for Members

The health and safety of our members, staff and clients is our main priority and CIAT is closely monitoring the Government's advice regarding the COVID-19 (Coronavirus) outbreak. The Institute continues to work hard to ensure that CIAT is still operating and supporting its membership during this period of uncertainty.

We strongly recommend regularly familiarising yourself with the information provided by the Government and the HSE. Information on COVID-19, the symptoms and how to protect yourself can be found on the HSE website. On **Thursday 14**May 2020, a C-19 Email Circular was distributed to all Republic of Ireland Centre members prior to Phase 1 of the Roadmap to ease COVID-19 restrictions and reopen Ireland's economy and society. This email included important information on Returning to Work, Business Continuity, Site Operating Procedures and C-19 Site Induction. We hope you found this helpful in assisting your return to work.

The management of COVID-19 continues and we recommend all member to monitor the Government and HSE websites for the latest and most accurate information. Important Update on the Architectural Technologists Register (ATR)

Progress is ongoing and the Register will now operate in a robust manner so that the Department and the Minister may make the necessary changes to the primary legislation to establish the Register as a Statutory Body, enabling **Registered Architectural Technologists** to act as **Design and Assigned Certifiers** under **BC(A)R 2014**.



We have identified a number of professionals in the construction industry who are willing to accept positions on the various boards required to administer the **ATR**. In total, we require 17 non-Architectural Technologists for these positions and, to date, have identified 13 non-ATs. Members are again urged to assist the process in a positive manner by identifying colleagues and acquaintances who are not Architectural Technologists yet hold relatively senior positions in the construction industry and who would be willing to accept a position on one of the four Boards / Committees as below. President's Virtual 'Visit' to Republic of Ireland Centre

On Tuesday, 16 June 2020, **Eddie Weir PCIAT** made a remote 'visit' to the Centre to meet with the membership and provide an update on the Institute's response to COVID-19 as well as other new and work pertinent to the Centre.

The President opened noting the largest attendance from a Region / Centre to date and gave an account of the Institute's response to COVID-19 including guidance on contractual issues, freezing of membership fees at last years rates, a dedicated webpage on the pandemic and Region / Centre support through co-operation with their Committees. He advised that decisions have also been made to hold the **AT Awards** and **AGM 2020** as remote events. The AT Awards | Excellence closed on **29 June 2020** and the AT Awards | Student has been extended to **4 September 2020**. The President also provided an update on the Institute's **Sustainability / Climate Action Plan**.

In relation to the ATR, the President advised that, due to COVID-19 and allocation of resources for same, most of the work has been paused. He advised all present that the formation of the ATR was fully supported by the Executive Board at it's meeting in February 2020 and it is a standing item on the Agenda going forward. At present, the Department of Housing, Planning and Local Government require the formation of a 'shadow' Register, complete with all the required boards, to demonstrate robust operation before being put on a statutory footing.

In terms of raising the profile of the Institute, the President referred to the NI Region who recently formed a PR Sub-Committee to help public recognition of the CIAT brand. He appealed to all Chartered members to promote where possible, through use of the title 'Chartered Architectural Technologist' together with the post-nominals MCIAT. Also, if members have any news or updates, projects they wish to promote etc., to contact Central Office for publication in the AT Journal or inclusion in the AT Weekly E-Newsletter.

The Institute continues in it's efforts to obtain clarification from the Companies Registration Office (CRO) regarding the use of the word 'architecture' in titles of practices operated by Chartered Architectural Technologists. The President advised to use 'Architectural Technology Services' or similar in registering companies while this is being addressed.

There were some questions and information updates from attendees when the visit was opened to all attending including an update from Gillian Fletcher MCIAT on the draft Proposal for Government. According to the draft proposal, the next Government will examine the creation of an independent Building Standards Regulator to oversee building control nationwide and re-establishment of the Building Regulatory Advisory Body (BRAB) - a positive step!

In closing, the President provided an update on the **Public Body Engagement Project**. It is currently being piloted in the Northern Ireland and Greater London Regions, with positive feedback from both. The purpose of the project is to promote Architectural Technology and its members as a profession to public bodies such as Local Authorities to ensure that **CIAT**

are listed alongside fellow professional bodies, architects and surveyors and can bid for projects as a 'designer / contract lead'. This can be achieved through use of a generic descriptor such as 'designer' or 'competent professional' as opposed to the 'architect' descriptor. In the Republic of Ireland, this is hindered at present due to BC(A)R but will arrive once the 'niggles' are ironed out. Guidance and training will be provided with the ultimate goal of the introduction of an Award for Public Procurement Project at the AT Awards.
