### Architectural Technologists (Shadow) Register (ATR) Live - Call for Renewals

Since the launch of the AT (Shadow) Register on **1 May 2023**, the Admissions & Assessment Board has received training and convened on five occasions. We're delighted to advise that there are **92 Full ATR Registrants** who have successfully applied, been admitted and are now listed on <u>www.architecturaltechnologistregister.ie</u>. This includes the first unaffiliated Architectural Technologist who applied directly to join the ATR and was successful in becoming a Full ATR Registrant.

## ARCHITECTURAL TECHNOLOGISTS' REGISTER

As we now approach the first ATR subscription **renewal date of 1 May 2024**, we're calling on all ATR Registrants to renew their subscription for a further year, fulfilling an agreed milestone with the **Department of Housing, Local Government & Heritage**. Prompt renewal will enable us to seek a meeting with the Department as soon as possible with the view to demonstrate we have fulfilled the agreed milestones and endeavour to obtain a timeline for implementation of a statutory register. The Registrations Administrator will be in direct contact with registrants in relation to the renewals process.

The need to demonstrate demand and viability remains and now is the ideal time to apply. Remember, the purpose of the ATR is much more than providing the facility to act in the roles of Design and/or Assigned Certifier. Through demonstration of demand and achieving statutory recognition, Full ATR Registrants will achieve recognition on par with other registered professionals (Chartered Engineers, Registered Architects and Registered Building Surveyors).

The process for **Chartered Architectural Technologists** is **streamlined** having already demonstrated their knowledge, experience and competence to gain Chartership. All that is required is the following:

- 1. An up-to-date CV (max. 2 pages) and;
- 2. Payment of the €200 ATR subscription
- 3. Application issued to atr@ciat.global

CIAT will then issue a letter of support confirming your eligibility for registration and this will be added to your ATR Admissions Board submission.

There is no time to delay! Do not assume other members will apply and you can join later when it becomes Statutory. CIAT and members and affiliates in Ireland have been campaigning and working tirelessly for over 10 years on behalf of all practicing Architectural Technologists for the introduction of a Statutory Register for competent Architectural Technologists. As previously mentioned, this is not only to allow registrants to act as **Design and/or Assigned Certifier** but to gain **recognition and parity** for the profession in Ireland, and secure the future of the discipline, for those who are studying Architectural Technology in our third-level institutes.

#### International Congress on Architectural Technology (ICAT) Conference 2024

This year, the Congress was an in-person event and took place in ATU Galway City on 18/19 January 2024. On Thursday, 18 January, the Republic of Ireland Centre Committee and aspirATion Group were delighted to partner with O'Neill O'Malley Architects, Galway, to sponsor a Student Challenge, which was open to all third-level institute / university students of Architectural Technology. A competition brief, prepared by Irene Hayden MCIAT with support from Karl Dempsey MCIAT, was circulated and made available prior to the event. I was delighted to secure competition judges for the event, namely CIAT President, Eddie Weir PCIAT, and Emma Hayes MCIAT, together with John O'Malley of O'Neill O'Malley Architects to review the submissions on the day. The format was simple, students were grouped and advised of the programme in the morning, having already received the brief, and staff from O'Neill O'Malley Architects were present to offer support. While the winter storm hindered students' attendance, there was great appetite from those who participated.

In the afternoon, each group gave a short presentation to the judges and the winners were announced on the day. The award categories and criteria as follows:

**Best Demonstration of Buildability / Assembly** - this is to recognise students' awareness of sequence of construction and buildability.

Best Application of Sustainable Materials - this will encourage students to explore alternative materials with an emphasis on local sourcing, carbon content, lifecycle, etc.

**Overall Winner** - this would demonstrate clearly achieving all the requirements set out in the brief together with performance in a short presentation. Congratulations to the ATU, Galway team on winning this category.

Sincere thanks to our judges, Eddie Weir PCIAT, Emma Hayes MCIAT and John O'Malley would made the trip through the adverse weather and devoted their time on the day.

The **ICAT Conference** took place on Friday, 19 January, with Conference Chair, **Irene Hayden MCIAT**, opening the conference with a warm welcome and sincere thanks to all sponsors including CIAT Republic of Ireland Centre & aspirATion Group, **Unilin Insulation** and O'Neill O'Malley Architects. Throughout the day, there were presentations from industry, educators, researchers, and the next generation of built environment students and professionals, including Eilis O'Hare ACIAT and Barry McCarron FCIAT with Gareth Alexander MCIAT chairing the afternoon session of the presentations.

In concluding the congress, Dr. Malachy Mathews FCIAT, ICAT Board Chair, spoke on the progress of the ATR and the need for full support from the AT community for it to succeed.

### ZEB Summit & revised European Performance of Buildings Directive (EPBD)

The **ZEB Summit** took place on the 21-22 of February 2024, commencing with an interactive workshop at the Dún Laoghaire-Rathdown County Council offices on Wednesday and delving into the innovative Shanganagh Castle **Passive House** Development.



The Summit Conference and Exhibition took place on Thursday showcasing the latest in EU legislation and groundbreaking technologies. Speakers included

Ciarán Cuffe MEP and rapporteur for the Energy Performance of Buildings Directive (EPBD); Pat Barry CEO of Irish Green Building Council (IGBC); Tomás O'Leary of MosArt; and our own Dr. Barry McCarron FCIAT, Vice-Chair of the Passive House Association of Ireland (PHAI).

The day commenced with Ciarán Cuffe's engaging presentation on the state of the energy market in the EU and steps towards the **revised Energy Performance of Buildings Directive (EPBD).** Following the opening presentations, there were 3no. streams of talks covering Zero Emission Leadership, Future Skills & Technology and Embodied Carbon & Retrofit. The conference was well attended and the presentations were both engaging and thought-provoking.



In the weeks following the ZEB Summit, Ciarán Cuffe MEP announced that the EPBD was voted through the European Parliament with a strong majority. This new law mandates zero-emission buildings from 2030, as well as renovation of the existing building stock prioritising the worst performing buildings. Electric vehicle charging and rooftop solar photovoltaics will become the norm. Energy efficiency measures such as heat pumps, insulation and heat recovery will be boosted, and greater availability of EU finance for energy upgrades. ### **Building Regulations | Key Updates**

#### Technical Guidance Document B1 - Fire Safety (2024)

On 26 March 2024, the Minister of Housing, Local Government and Heritage signed regulations entitled 'Building Regulations (Part B Amendment) Regulations 2024 (S.I. 108 of 2024)'. The new regulations come into effect on **1 May 2025 (note a variety of transitional arrangements apply)**. An updated Technical Guidance Document B has been published to accompany the Regulations in respect of Fire Safety in Buildings other than Dwelling Houses. We have summarised the primary amendments as follows:

- Inclusion of a more specific scope
- Provision of a sprinkler system in buildings containing flats, or student accommodation units with a topmost floor height of > 15 m, multi-storey Residential (care facility) buildings and reductions in compartment sizes and risk associated with specific building types which incorporate a sprinkler system
- Provision of a fire resisting flanking wall, where a compartment wall meets an external wall.
- Removal of the option of Diagram 17 for new buildings/extensions
- Changes to the fire performance of external walls to inhibit fire spread
- Additional provisions for elements attached to the building, outside the thermal envelope
- New provisions for enhanced internal firefighter access to buildings, with a topmost floor height > 11 m, but < 20 m</li>
- New Sections Section 6 for smoke control systems; Section 7 for existing buildings and Section 8 for sprinkler systems
- Inclusion of high-rack storage > 7 m, as 'High Hazard' under Appendix E
- Change in provisions relating to the ventilation of protected escape stairways
- Additional provisions relating to the provision of additional materials to the external walls of existing buildings
- Additional provision to provide insulated doors/shutters, where a door/shutter forms more than 25% of a compartment wall
- The new TGD has 8 appendices and 93 diagrams instead of instead of 7 appendices and 38 diagrams in the 2006 version.

Members and affiliates are strongly advised to familiarize themselves with the new document. Click the following link to download <u>Technical Guidance Document B1</u>. The Centre will arrange a CPD on this subject later in the year.

#### Technical Guidance Document M - Access & Use (2022)

A reminder that as of 1 January 2024, changes to Part M of the Building Regulations (S.I. 608 of 2022) now require a Changing Place Toilet to be included in certain new buildings and buildings undergoing alteration or extension. This means larger supported facilities must be available to address the needs of people for whom current accessible sanitary accommodation is inadequate.

Changing Places Toilets enable people with complex care needs to participate in everyday activities such as travel, shopping, family days out or attending a sporting event.

Transitional arrangements apply for projects where work commenced or planning was applied for before 31 December 2023. Click the following link to download <u>Technical Guidance Document M</u>.
