It's the awards season! Following the success of last year's event and the easing of restrictions, this year will see a hybrid event with a limited number of guests in attendance and all others joining remotely. The past two months have been eventful with the release of '**Housing for All – a New Housing Plan for Ireland**', the government's housing plan to 2030, **Budget 2022** and the publication of Eoin Ó Broin's latest book '**Defects; Living with the Legacy of the Celtic Tiger**'. Being unable to put it down once I started, this is a sobering and essential read for all members of the construction industry. From the personal stories of homeowners effected by building defects in Part 1 to a detailed insight into the protracted development of the Building Regulations in Part 2, the problems associated with self-certification and the need for real reform.

The '**Housing for All**' Plan replaces the '**Rebuilding Ireland Strategy**' launched in 2016. It's primary objective is to address Ireland's continuing housing crisis, requiring the public and private sectors to work together to reach the overall target of 300,000 homes by 2030 with the State intending to spend €4 billion a year to 2030 on various State interventions and capital investments. Since it's release, there have been assessments on the density of developments in Ireland to achieve higher 'dwelling per hectare (dw/ha)' ratios (similar to our European counterparts). However, as well as density, it's about design – well-considered, sustainable design enhances developments and increases desirability as people care about the look, feel and livability of their community together with respect for the environment and our sustainable future.

As always, I hope you find this quarter's Newsletter informative and encourage you to submit any suggestions you have for future content, be that case studies of completed projects, news and updates for our quarterly newsletter, social media content suggestions or other.

### Important Update on the Architectural Technologists Register (ATR)



On 25 March 2021, a meeting was held with the **Department for Housing, Local Government and Heritage** where they promised to report back and provide guidance on the most seamless route for ATs to gain Statutory recognition to act as **Assigned and/or Design Certifiers**.

Following the meeting in March, CIAT were asked to meet with the **Society for Chartered Surveyors, Ireland (SCSI)** who manage the Building Surveyors Register to explore the possibility of implementing an AT Register in collaboration. The SCSI intimated that this could present a conflict with their constitution and we are in communication with the Department and SCSI to conclude the matter and progress the ATR.

Members and affiliates are encouraged to maintain the sustained pressure on the Minister/Department via their local TDs to ensure we can achieve a **Statutory Register** as soon as possible.

The **ATR Code of Conduct** has submitted to the **Competition and Consumer Protection Commission (CCPC)** as required under Part 6 of the Building Control Act 2007 for review. A response is still awaited.

The number of Architectural Technologists registering on the **ATR** is increasing slowly, with 259 MCIAT members on the Register and 197 applicants having registered their Intention to Register. It is essential that all CIAT members prevail upon their unaffiliated Architectural Technologist colleagues to assist CIAT in gaining the appropriate recognition for our profession by joining CIAT or registering on the ATR. ## PI Insurance Issues



Following the update in our Summer Newsletter, the challenges associated with securing adequate Professional Indemnity Insurance, primarily in respect of fire safety design, continues for a large number of our members and affiliates as well as other professionals in the wider construction industry. Further to correspondence with insurance brokers and members who have been successful in obtaining adequate insurance cover, it appears to be on a case-by-case basis with the requirement to complete a supplementary risk assessment questionnaire.

### What can you do?

If your insurance policy is up for renewal this year, engage with insurers as early as possible (not just weeks ahead but months) and provide as much information within your proposal form to secure adequate PI Insurance, discussing the nature of any exclusions with your insurance brokers in detail. Also, given the potentially substantial change in your insurance cover, you may also need to review your contractual agreements with your clients to ensure that you can still comply with any agreed insurance limits.

ATs are not the only professionals affected by this exclusion policy as engineers, architects and surveyors also face the difficulty of obtaining adequate PI Insurance. We encourage members and affiliates to lobby their local TDs to ensure this issue is addressed as it will only compound the current housing crisis being faced.



## Building Regulations - Part L 2021

Further to signature of the European Union (Energy Performance of Buildings) Regulations (S.I. No. 393 of 2021), the Minister of Housing, Local Government and Heritage, Darragh O'Brien, has amended [Technical Guidance Document Part L \(2021\)](#) of the Building Regulations. This introduces regulations on **Building Automation and Control Systems and Electrical Vehicle Re-Charging Points** for all new buildings, including dwellings, and for all existing buildings other than dwellings.



In existing buildings other than dwellings with more than 20 car parking spaces, a minimum number of charging points will be required. Certain requirements shall not apply to a building or works where the submission of a Commencement Notice with respect to such works has been lodged on or before the 10th of March 2021. However, it is likely that such buildings would fall under the status of existing building and have requirement to meet the standards specified for existing building other than a dwelling before 1 March 2025, where technically and economically practicable.

Also, in addition to **Technical Guidance Document Part L (2021)**, the **Acceptable Construction Details (ACDs) 2021** have been issued with greater focus on thermal bridging and airtightness - these can be found [here](#).
